## What people told us

#### Availability of records and notes

Information was not consistently shared between departments, teams, hospitals and GPs.

Cross-border information sharing (commissioning and national borders) is poor and a blocker to good care.

#### **Reliving trauma**

People had to repeatedly share their experiences of miscarriage, stillbirth or complications at appointments, resulting in them reliving their distress and trauma.

#### Having to be responsible

Lack of consistency and joined-up systems meant many service users had to selfadvocate and 'own' their information and history.

#### Individual support needs

Teams seemed unaware of the support needs of some service users which meant interpreters were often not booked and therefore unavailable or women were treated in environments where they felt uncomfortable.

#### **Reflecting individuals**

Current systems for recording information aren't flexible enough to reflect different circumstances or family backgrounds.

#### Feeling safe and reassured

When teams had access to information and appeared to be knowledgeable, this gave people reassurance they were safe.

## Spotlight on: Amanda's story

"On the day of my induction, I was messaging my midwife to get my records from [hospital A] sent to [hospital B] because they had no information on me... so **I'm being induced with them asking me my blood type**, all my information about my whole pregnancy because none of that was in [hospital B] with me."



"I had to phone my community midwife to get my own information sent, while being induced, which was **not a very nice experience.**"
