## Person characteristic Discovery for NHS England

PRSB has recently been awarded a contract with NHS England to gather intelligence on the clinical requirements relating to person characteristics, as they develop a draft model of suggested data items including definitions, for each characteristic. We are delighted to be working in partnership with FEDIP (Federation for Informatics Professionals in Health and Care) on a discovery phase of work and will be engaging broadly on the model from October to January 2025.

## Members priorities for standards 2024-25

Building on previous Advisory Board discussions, we are seeking a consensus view from our members and stakeholders on our priorities in the following categories:

- □ Initiating key gaps and areas where **new standards** would be beneficial
- □ Improving where significant work is needed to existing standards to improve their usefulness
- □ Implementing where focused effort is needed to drive uptake of a specific standard

We would very much appreciate your feedback on both our prioritisation criteria and the standards themselves. A proposed short list is reflected in the October slides (attached in this email) and we will be circulating a survey to facilitate further feedback shortly. The information will be used to influence commissioners and policy makers and to actively seek funding in the areas our members tell us are most important.

## **Coalition for change**

At our July advisory board, we brainstormed priority actions aligned with our five strategic missions. Thanks to members' enthusiasm, we launched our coalition for change at the September AGM (see <u>here</u>). We welcome your feedback on whether our priorities are on track. Our upcoming *Start with Standards* campaign will focus on promoting the role of standards in improving care, and we'll keep you updated with ways to get involved.
