



## **Advisory Board actions and key messages 21 January 2025**

This note summarises the key information for sharing and actions for members arising from the 21 January 2025 Advisory Board. It is intended as an aide memoire for members and Advisory Board representatives, for onward distribution within your organisations as appropriate.

### **Chair and CEO update**

Our new Chair, Professor Reecha Sofat, is gradually managing to meet member organisations individually and we will be in touch to arrange more in due course.

Alison Errington Orr, new Director of Marketing and Communications at PRSB, was introduced and will be in touch.

The PRSB is currently facing a challenging financial situation. A significant proportion of our funding comes from NHS England and the freeze on finances in NHS E is having a knock-on impact on our financial position. PRSB are in discussion with NHS England on ways to mitigate this as well as continuing to pursue alternative options to futureproof the organisation and protect our vital work. Member support will be crucial during this period and we will be in touch to discuss further how you can support us.

### **Work programme update**

PRSB had made positive progress on the Person Characteristics projects, the initial consultation is complete, and the results are being analysed.

### **Standards Partnership Scheme for software suppliers**

There are four new Standards Partnership Scheme members, Anchor, Ethos, RoundSys and Heath Diagnostics.

### **Four Nations working group**

#### Obstetric Anaesthesia minimum dataset (Obstetric Anaesthetic Association)

*Development of minimum dataset to standardise obstetric anaesthesia records, enabling improved care and audit. We will be consulting with relevant professionals during the Spring.*

#### Data Management in General Practice (NHS England - CISS)

*Development of data definitions that will enable more accurate recording of activities such as 'consultation types' in General Practice. Consultation on the standard undertaken and guidance developed.*

#### NHS Health Check (Department of Health and Social Care - CISS)

*Development of an information standard for Physical Health checks.*

#### Diabetes Implementation (NHS England)

*Support for technical implementation and piloting of diabetes standards plus an implementation toolkit and templates and preparation for upcoming commission on Continuous Glucose Monitoring profile*

#### Common Data Model (NHS England)

Assessment of PRSB + other standards against proposed CDM and engagement with stakeholders on proposed model

#### Epilepsy standard (RCPCH)

Development of standard and implementation following RCPCH funded initial work (now published on our website).

#### Data (Use and Access) Bill – DCF discovery

Assessment of standards required by the DCF framework and report to NHS England

#### London Ambulance Service – review of Case Summary and compliance with standards

Review of Cleric ePCR's Case Summary which is sent to hospitals against compliance to most appropriate PRSB Standard (e.g. Ambulance handover to emergency care standard) to understand compliance and potential remediation required.

*Consultation on proposed person characteristics and endorsement from professional bodies*

#### HIQA – Ireland

*Training and development for new HIQA standards team learning from PRSB's experience*

Short discovery to determine how the RCOPHTH Clinical Data Sets can be fully developed and implemented

Discovery to determine review the options for using data standards to improve women's health. We want to know how could better use of existing information standards accelerate improvements in women's health, and what would the impact be and what are the gaps in existing standards or new standards that are required that would achieve a significant impact in improving women's health and delivering the women's health strategy for England?

#### Introducing Standards for Case Management Systems (Department of Health and Social Care)

Development of a specification for Social Care Case Management Systems. Consultation and requirements gathering and specification development. Work is being procured openly
